### THE DISASTER RISK MANAGEMENT ACT

The Disaster Risk Management (Enforcement Measures) (No. 4) (Amendment) Order, 2020

WHEREAS the Minister responsible for disaster preparedness and emergency management has given written notice to the Prime Minister that Jamaica appears to be threatened with or affected by the SARS - CoV-2 (Coronavirus COVID-19), and that measures apart from or in addition to those specifically provided for in the Disaster Risk Management Act should be taken promptly:

AND WHEREAS on the 13th day of March, 2020, the Prime Minister by Order declared the whole of Jamaica to be a disaster area:

#### NOW THEREFORE:

In exercise of the powers conferred upon the Prime Minister by section 26(2) of the Disaster Risk Management Act, and every other power hereunto enabling, the following Order is hereby made:—

1. This Order may be cited as the Disaster Risk Management (Enforcement Measures) (No. 4) (Amendment) Order, 2020, and shall be read and construed as one with the Disaster Risk Management (Enforcement Measures) (No. 4) Order, 2020, hereinafter referred to as the principal Order.

2. Paragraph 15(1) of the principal Order is amended by deleting the words "5:00 am on April 22, 2020, and ending at 6:00 am on April 28, 2020" and substituting therefor the words "6:00 am on April 28, 2020, and ending at 6:00 am on May 1, 2020".

3. The Second Schedule of the principal Order is amended—

- (a) in the heading, by deleting the words "6:00 am to 6:00 pm" and substituting therefor the words "6:00 pm to 6:00 am";
- (b) by inserting next after item 27 the following items—

" 27A. Persons employed or contracted, to undertake construction, by a person to whom a licence or permit to carry out such construction is issued under any law.

27B. Persons employed or contracted to catch, land or process fish, pursuant to a licence or permit issued under the Fisheries Act.

27C. Duties in respect of the urgent need to care for livestock, fish or other animals or crops.".

- 4. The Third Schedule of the principal Order is amended-
  - (a) in item 3, by inserting next after the word "electricity," the words "public works,";
  - (b) by inserting next after item 18 the following items—

" 18A. Persons engaged in construction pursuant to a licence, or permit, issued under any law.

18B. Persons engaged in catching, landing or processing fish pursuant to a licence or permit issued under the Fisheries Act.".

5. The Fourth Schedule of the principal Order is amended by inserting next after item 38 the following items—

" 38A. Duties as a person employed or contracted, to undertake construction, by a person to whom a licence or permit to carry out such construction is issued under any law.

38B. Duties as a person employed, or contracted, to catch, land or process fish pursuant to a licence or permit issued under the Fisheries Act.".
